All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate on the West side of Scarlett Street (formerly known as Forest Green Road), near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 224 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, revised through December 1953, recorded in the R.M.C. Office for Greenville County in Plat Book "GG" at pages 70 and 71, and having, according to said plat, the following metes and bounds, to-wit:

EEGINNING at an iron pin on the West side of Scarlett Street at the joint front corner of Lots Nos. 223 and 224 and running thence with the line of Lot No. 223, S. 88-59 W. 160.4 feet to an iron pin; thence N. 4-26 E. 90 feet to an iron pin; thence with the line of Lot No. 225, S. 85-39 E. 161.3 feet to an iron pin on the West side of Scarlett Street; thence along the West side of Scarlett Street S. 5-41 W. 75 feet to the beginning corner. Being the same property conveyed to the grantor by Thomas D. Christopher by deed dated January 6, 1955, recorded in Deed Book 515 at page 432.

This property is conveyed subject to restrictions which are of record in the R.M.C. Office for Greenville County in Deed Book 492 at page 221.

As part of the consideration hereof the grantees agree to assume and pay, according to its terms that certain note and mortgage executed by the grantor to General Mortgage Co., assigned to Mutual Benefit Life Insurance Company, on which there is a balance due of \$9,790.64, said mortgage being recorded in Mortgage Book 620 at page 221.
