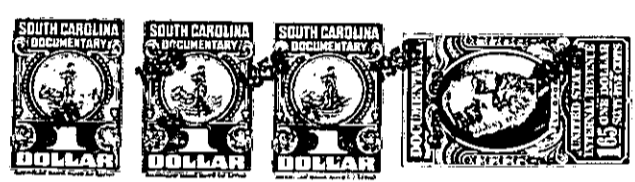

P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated at Lot 7 of a subdivision known as Hutton Court, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book NN at Page 101, and having the following metes and bounds, to wit:

BEGINNING at a point on the Western side of Hutton Court at the joint front corner of Lots 6 and 7 and running thence N 75-21 W 170.3 feet to a point at the joint rear corner of Lots 6 and 7; thence N 05-15 W 92.6 feet to a point; thence N 76-37 E 174.9 feet to a point at the joint rear corner of Lots 7 and 8; thence S 16-21 E 142.4 feet to a point on the Northern side of Hutton Court at the joint front corner of Lots 7 and 8; thence following the curvature of a turnaround at the Northern end of Hutton Court S 43-39 W 50 feet to the point of beginning.
