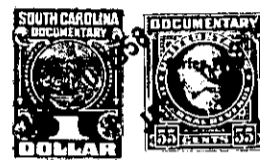
Know All Men by These Presents:

Stevens, his heirs and assigns, forever:

all that certain piece, parcel or lot of Land situate, lying and being in the County and State aforesaid, on the W/S of U. S. Highway no. 276 about one mile SE of the town of Marlotta, being shown as Lot no. Sixteen (16) on a plat of survey of Linda Acres made by J.C. Hill, surveyor; May 2, 1957, and having, according to said plat, the following notes and bounds, courses and distances, to-wit:
