All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, lying on the southern side of Edwards Road in Butler Township, near the City of Greenville, being shown as Lot No. 1 on a plat of Lake Forest Heights, Section 1, prepared by Piedmont Engineering Service, dated November, 1955, recorded in Plat Book GG, Page 153, and according to said plat being more particularly described as follows:

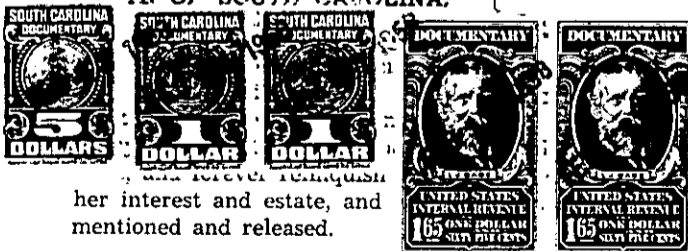
