BEGINNING at an iron pin on the West side of Donnan Road at joint front corner of Lots 12 and 51, and running thence with the line of Lot 12, N. 88-10 W., 342 feet to an iron pin; thence N. 1-50 E., 99 feet to an iron pin; thence with the line of Lot 50, S. 88-10 E., 342 feet to an iron pin on the West side of Donnan Road; thence along the West side of Donnan Road, S. 1-50 W., 99 feet to the point of BEGINNING.

As a part of the consideration the grantees assume and agree to pay the balance on that certain mortgage from Wally R. Williamson to Shenandoah Life Insurance Company in the original amount of \$8,000.00, on October 29, 1953, recorded in the R. M. C. Office for Greenville County in Mortgage Book 577, at page 215, the balance on said mortgage as of this date being \$6,896.38.
