That Derby Heights Inc, a corporation in the State aforesaid, in consideration of the sum of TWO THOUSAND AND NO/100----- DOLLARS,

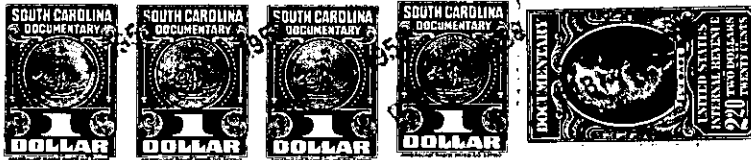

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 292 according to a survey of Belle Meade Subdivision(Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187. Said lot fronts on Lancaster Lane and is more particularly described as follows:

BEGINNING at an iron pin on the north side of Lancaster Lane, joint front corner of Lots 291 and 292 and running along Lancaster Lane N. 43-40 W. 85 feet to an iron pin, joint front corner of Lots 292 and 293; thence along the line of Lot 293 N. 50-35 E. 161.5 feet to an iron pin, joint rear corner of Lots 292 and 293; thence along the rear line of Lots 303 and 304 S. 26-13 E. 55.9 feet to an iron pin, joint rear corner of Lots 291 and 292; thence along the line of Lot 291 S. 38-30 W. 145.3 feet to an iron pin on Lancaster Lane, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 552, at Page 473.

The grantee is to pay 1958 taxes.
