Know All Men by These Presents:

That I, WILLIAM R. TIMMONS, JR.,
in consideration of the sum of ONE THOUSAND AND NO/100-----(\$1,000.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. W. MANLEY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lots Numbers 28 and 29 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Woodbriar Court at the joint front corner of Lots 27 and 28 and running thence S 31-15 E 251.5 feet to a point at the joint rear corner of Lots 27 and 28; thence S 36-43 W 128 feet to a point at the joint rear corner of Lots 28 and 29; thence S 36-43 W approximately 106.9 feet to a point in a branch, the rear corner of Lot 29; thence with said branch as a line approximately N 40-24 W approximately 130.2 feet to a point; thence continuing with said branch as a line approximately N 22-09 W approximately 136.1 feet to a point; thence with the Southeastern side of Woodbriar Court N 39-25 E approximately 41.15 feet to a point; thence following the curvature of a turn around radius circle at the Southwestern end of Woodbriar Court (the chord of which is N 65-09 E 56.3 feet) to a point at the joint front corner of Lots 28 and 29; thence following the curvature of a turn around radius circle at the Southwestern end of Woodbriar Court (the chord of which is N 05-24 E 43.7 feet) to a point; thence with the Southeastern side of Woodbriar Court N 39-25 E 102.1 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of way.

GRANTEE to pay 1958 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
