to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HORACE A. PULLIAM, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, designated as Lot # 10 on a plat of property of Walter J. Farr, recorded in the R.M.C. Office for Greenville County in Plat Book HH at page 123, and having, according thereto, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Leland Circle at the joint front corner of Lots # 9 and 10, and running thence along the line of said lots N. 82-50 E. 185 feet to an iron pin; thence S. 7-10 E. 90 feet to an iron pin; thence S. 82-50 W. 185 feet to an iron pin; thence along the Eastern side of Leland Circle N. 7-10 W. 90 feet to the point of beginning.
