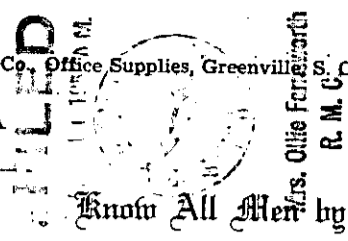

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 15 on a Plat of Marion Grove subdivision, recorded in the R. M. C.
