That I, George F. Townes, as Trustee for G. W. Strickland and in the State aforesaid, in consideration of the sum of \$1.00 and the premises James E. Burger DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James E. Burger, his heirs and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot #5 of a subdivision known as Glendale Heights as shown by a plat thereof made by J. Mack Richardson, February, 1958 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Cross (Jacobs) Road at the joint front corner of Lots #4 and #5 and running thence with the northern side of Cross Road, N. 60-55 E., 72 feet to a pin at the corner of Lot #6; thence with the line of Lot #6, N. 29-05 W., 140.5 feet to a pin in the Line of Lot #7; thence with the line of Lot #7, S. 60-55 W., 72 feet to a pin at the corner of Lot #4; thence with the line of Lot #4, S. 29-05 E., 140.5 feet to the beginning corner.

This is the same property conveyed to me as trustee by James E. Burger and G. W. Strickland by deed dated January 29, 1958 and recorded in the Greenville County R. M. C. Office in Vol. 592, at page 135.

James E. Burger owns the beneficial interest in this lot, and this deed is executed simply for the purpose of conveying to him legal title to this lot free of the trust.

The plat of this property referred to above is recorded in Plat Book "KK", at page 143 in the Greenville County R. M. C. Office. This lot is subject to restrictions of record.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
