

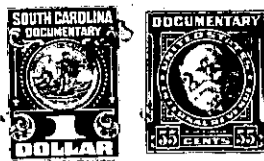

Owens, his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, lying between Avice-Dale Drive and Bagwell Avenue, containing seventy-five one hundredths of an acre and being known as Lot No. 5 of the property of W. T. Looper, and, according to a plat recorded in the R. M. C. Office for Greenville County, having the following metes and bounds, to-wit:
