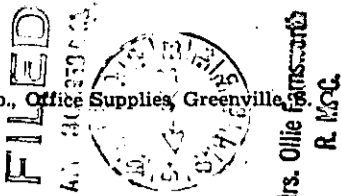

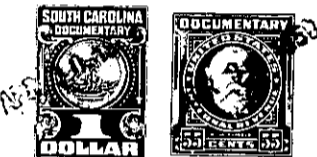
ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 206 as shown on a Plat of Section No. 2, Caroline Court, dated November 1953 by Dalton & Neves, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 21, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Manhattan Boulevard at joint front corners of lots 205 and 206 and running thence along the lines of said lots, S. 25-15 W. 240 feet to iron pin at rear corner of lots 210 and 209; thence running with rear line of Lot 209, N. 64-45 W. 100 feet to iron pin at rear corner of Lot 207; thence running with line of said lot, N. 25-15 E. 240 feet to iron pin on Manhattan Boulevard; thence running with said Boulevard, S. 64-45 E. 100 feet to iron pin at point of beginning.
