All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, the County of Greenville, State of South Carolina, being known and designated as Lot No. 174, Section III, Lake Forest Subdivision, as per plat thereof, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "GG", page 77, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Rockmont Road, joint front corner Lots 173 and 174; and running thence S. 65-52 W. 171.4 feet to an iron pin, joint rear corner Lots 173 and 174; thence along the line of Lot 175 S. 17-35 E. 125 feet to an iron pin on Wendover Drive; thence along Wendover Drive N. 77-58 E. 80 feet to a point; thence continuing along Wendover Drive N. 81-49 E., 61.6 feet to an iron pin; thence around the curve of Wendover Drive and Rockmont Road, the chord of which is N. 33-0 E. 32.9 feet to an iron pin on Rockmont Road; thence along Rockmont Road N. 15-49 W. 141.2 feet to an iron pin, the point of beginning.
