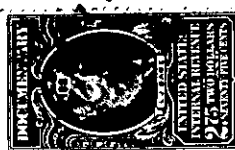

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JOHN C. COTHRAN, his heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, in Greenville Township, being known and designated as LOT NO. 17 on Birchwood Drive, and being shown on plat of Subdivision known as KIRKWOOD HEIGHTS according to a Survey made by Pickell & Pickell, Engineers, October 1954 and recorded in the RMC Office for Greenville County in Plat Book EE, at pages 110 and 111 and having the following metes and bounds according thereto:

BEGINNING at an iron pin at the joint front corner of Lots 17 and 18 and running thence along the joint line of said lots, South 49-18 East 150 feet to an iron pin; running thence North 40-42 East 78 feet to an iron pin; running thence North 49-18 West 150 feet to an iron pin on Birchwood Drive; running thence along Birchwood Drive, South 40-42 West 78 feet to an iron pin, the beginning corner.

This property is sold subject to the restrictive covenants, easements, and rights of way recorded against said Subdivision in the RMC Office for Greenville County in Deed Book 519, at page 439 and to the building line and other reservations as shown on the plat of Kirkwood Heights recorded in Plat Book EE, at pages 110 and 111, RMC Office for Greenville County.
