to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James E. Burger, his heirs and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot #8 of a subdivision known as Glendale Heights, as shown by a plat thereof made by J. Mac Richardson, February, 1958 and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 143, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Glendale Street at the corner of Lot #9 and running thence with the northern side of Glendale Street, S. 6-45 E., 33 feet to a concrete monument in the line of Lot #8; thence continuing with Lot #8, S. 0-48 E., 38 feet to a pin at the corner of Lot #7; thence with the line of Lot #7, N. 82-47 E., 133.7 feet to a pin in the subdivision property line; thence with the subdivision property line, N. 6-45 W., 70 feet to a pin at the rear corner of Lot #9; thence with the line of Lot #9, S. 83-15 W., 130 feet to the point of beginning.

This is the same property conveyed to me as Trustee by G. W. Strickland and James E. Burger by deed recorded in Vol. 592, at page 135.

This property is subject to restrictions of record.

The grantee owns the beneficial title to this property and this deed is made to extinguish the trust.
