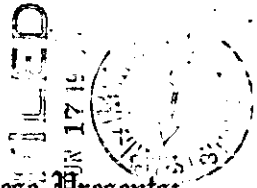

Know All Men by These Presents:

That I, M. W. Fore in the State aforesaid,  
in consideration of the sum of Six Hundred Ninety Five & NO/100 (\$695.00) - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lynwood S. Barnes and Frances Barnes, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lots No. 76 and 77 as shown on a Plat of Brookwood recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the South side of Gantt Drive at the joint front corner of Lots 75 and 76 and running thence with Gantt Drive, S. 87-45 E. 200 feet to iron pin corner of Lot 78; thence with the line of said lot, S. 2-15 W. 165 feet to an iron pin corner of Lot 58; thence with the rear line of Lots 58 and 59, N. 87-45 W. 200 feet to an iron pin rear corner of Lot 75; thence with the line of said lot, N. 2-15 E. 165 feet to the point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
