to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

W. L. Burger, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the northwesterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 7 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Selwyn Drive, which pin is located at the joint front corner of Lots 7 and 8, and running thence with the joint line of said lots N 42-31 W 214 feet to an iron pin; thence N 28-21 E 12.5 feet to an iron pin; thence N 68-21 E 137.3 feet to an iron pin, joint rear corner of Lots 6 and 7; thence along the joint line of Lots 6 and 7 S 26-23 E 185 feet to an iron pin on the northwesterly side of Selwyn Drive; thence with the northwesterly side of said Drive S 53-12 W 90 feet to the point of beginning.
