That I, Glynn A. Lindsey in the State aforesaid, in consideration of the sum of Five Thousand Two Hundred Thirty One & 14/100 (\$5,231.14) --- DOLLARS, and assumption of mortgage described below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Edward Rucker Goodson, his Heirs and Assigns:

All that piece, parcel or lot of land, situate, lying and being on the Southerly side of Brookside Circle, in the Southwest intersection of Brookside Circle and Beverly Lane, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 116, University Park, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, page 127, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin in the Southwest intersection of Brookside Circle and Beverly Lane and running thence along the Westerly side of Beverly Lane S. 37-34 E. 182.5 feet to an iron pin joint corner Lots Nos. 116 and 98; thence S. 52-26 W. 75 feet to an iron pin joint rear corner Lots Nos. 115 and 116; thence N. 37-34 W. 182.5 feet to an iron pin on the Southerly side of Brookside Circle joint front corner Lots Nos. 115 and 116; thence along the Southerly side of Brookside Circle N. 52-26 E. 75 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co., on which there is a balance due of \$6,135.86; said mortgage is recorded in Mortgages Volume 491, page 455.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

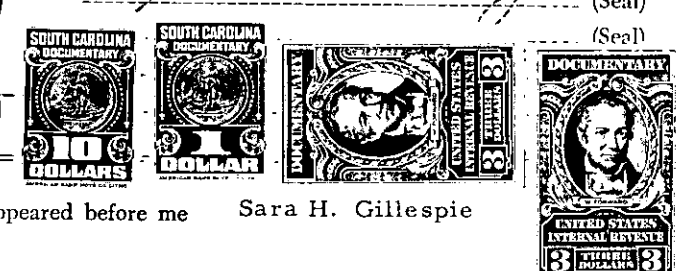
