That Edford D. Johnson in consideration of the sum of Eleven Hundred and no/100----- DOLLARS,

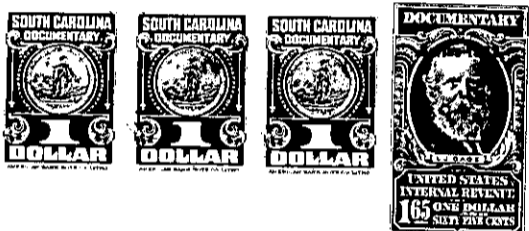
