to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

James A. Howard, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about five miles north of Greer, S. C., lying on the southern side of a community road that leads off of State Highway No. 14, and being a part of the same land that was conveyed to me by deed from T. L. & Beulah Forrester January 11th 1947, recorded in the office of the R. M. C. for Greenville County in Deed Book 306 at page 14, and having the following courses and distances, to wit:-

Beginning on a stake in the said community road at a distance of 150 feet, more or less, from the former J. C. Berry Estate line, and runs thence with the center of the said road S. 63-55 W. 100 feet to a stake in the said road; thence with the common line of this lot and of another lot being conveyed this day by me to Joann B. Howard, S. 26-00 E. 20 feet to an iron pin on the southern bank of the said road, then continuing with the same course for a total distance of 217 feet to an iron pin; thence N. 63-55 E. 100 feet to an iron pin; thence N. 26-00 W. 217 feet to the beginning corner (iron pin back on line at 17 feet), containing One Half (1/2) acre, more or less.
