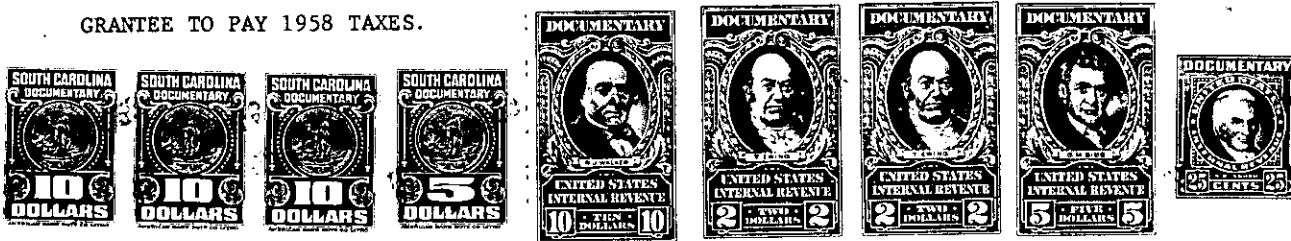
All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the easterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 23 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Selwyn Drive, joint front corner of Lots 23 and 24, and running thence along the common line of said lots N 84-16 E 192.4 feet to an iron pin; thence S 2-03 W 90.85 feet to an iron pin, joint rear corner of Lots 22 and 23; thence along the common line of said lots S 84-16 W 180.1 feet to an iron pin on the easterly side of Selwyn Drive; thence along said Drive N 5-44 W 90 feet to an iron pin, the point of beginning.
