to the grantor(s) in hand paid at and before the scaling of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said LOUISE M. MOORE, Her Heirs and Assigns Forever:

All that piece, parcel or lot of land, together with buildings and improvements situate thereon, lying and being in Butler Township, Greenville County, South Carolina, known and designated as Lot No. 95 on a plat of Lake Forest Subdivision, Section I, prepared by Piedmont Engineering Service in July, 1953, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", at page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Lake Fairfield Drive, joint front corner of Lot Nos. 94 and 95, and running thence along the line of Lot 94, S. 33-00 W. 218.8 feet to an iron pin, joint rear corner of Lot Nos. 94 and 95, at the high water mark of Lake Fairfield; thence running along the high water mark of said lake, the traverse line of which is N. 19-31 W. 130 feet to an iron pin, joint rear corner of Lot Nos. 95 and 96; thence along the line of Lot No. 96, N. 33-54 E. 141. I feet to an iron pin on the southerly side of Lake Fairfield Drive, the joint front corner of Lot Nos. 95 and 96; thence along the southerly side of Lake Fairfield Drive on an angle, the chord of which is S. 56-06 E. 105 feet to an iron pin, the point of beginning, subject to restrictions, easements and rights-of-way of record.
