All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township, being known and designated as Lot Number Eight (8) according to a map or plat of Oakland Terrace as made by C. C. Jones and Associates, Engineers, in June 1957, which plat is of record in the R. M. C. Office in Plat Book "BB" at page 196, said lot of land being described by metes and bounds according to said plat as follows, to-wit:

BEGINNING at an iron pin on the Southeastern side of Zelma Drive, as shown on said plat, at a corner common to Lots No. 7 and No. 8 and running thence along the dividing line between Lots No. 7 and No. 8 South 48-25 East 177.7 feet to an iron pin; thence South 41-55 West 100 feet to an iron pin at the corner of Lot No. 9; thence along the dividing line between Lots No. 8 and No. 9 North 48-35 West 175.57 feet to an iron pin on Zelma Drive; thence along the Southeastern line of Zelma Drive North 41-25 East 55.3 feet to an iron pin; thence continuing along said Zelma Drive North 39-30 East 44.7 feet to the place of beginning.
