An easement and right of way, for the purpose of construction, maintenance, use and travel, a road along, in, over and through, the certain strip of Land in: AUSTIN Township, Greenville County, State of South Carolina, being Thirty Six (36) feet in width at all points, beginning with the center line of the J. T. Massingale Road at corner of the J. T. Massingale Road and Austin Branch Road, continuing the same easterly along said old established road and the new continuation thereof, to the junction of said old established road in a generally southeasterly direction, with the old established road leading over and along said road of the park, the one easterly and the other southerly, and now no longer visible, to the termination of each as now established and existing; and I do further release, grant and quitclaim to the grantee(s) a tract of land owned by grantor hereinabove described, R. Moore land bounded by Little Oak, or formerly so called, by the S.C. R.R. Rd and Bradwell, and Green Creek, all of which is more particularly described in my Deed, dated April 1, 1958, to L. S., and set out, etc.
