to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mattie Lou McAlister and Dewitt McAlister, their heirs and assigns forever.

All that piece, parcel or lot of land situate, lying and being in Cleveland Township, known and designated as Lot No. 23 of a Subdivision known as Hart Valley Haven owned by Imogene T. Osteen and David W. Osteen, This conveyance is of Lot No. 23 of said subdivision according to a plat made by J. C. Hill, L. S. on March 10, 1955 and recorded in the R. L. C. Office for Greenville County, S.C. in Plat Book EE, at page 137, reference to which is hereby made.
