Office for Greenville County in Plat Book BB, at Page 61, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on Staunton Bridge Road at joint front corners of Lots Nos. 11 and 12 and running thence along the line of said lots, N. 69-20 W. 178.7 feet to iron pin at rear corner of Lots 22 and 23; thence running with rear line of Lot 22, S. 20-40 W. 82.5 feet to iron pin at rear corner of Lot 13; thence: running with line of said lot, S. 69-20 E. 182.6 feet to iron pin on Staunton Bridge Road; thence running with said Road, N. 23-00 E. 82.6 feet to iron pin at point of beginning. THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on any lot; no residence shall be erected on lots fronting on Polk Blvd. nearer than 30 feet to the front line, on Caroline Street & Lockman Drive nearer than 40 feet to the front line; no residence shall be built on any lot unless said lot has fifty feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks. THIS conveyance is subject to all easements and rights of way of record. GRANTEE to pay taxes for the year 1958. TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
