to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 9 of the property of W. T. Patrick and William R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Nicholas Drive at the joint front corner of Lots 8 and 9 and running thence S 55-40 W 130 feet to a point at the joint rear corner of Lots 8 and 9; thence S 34-20 E 142.7 feet to a point on the Northwestern side of Lawnview Court at the joint front corner of Lots 9 and 10; thence with the Northwestern side of Lawnview Court N 55-40 E 105 feet to a point; thence following the curvature of the Northwestern intersection of Lawnview Court with Nicholas Drive (the chord of which is N 10-40 E 35.3 feet) to a point; thence with the Southwestern side of Nicholas Drive 117.7 feet to the point of beginning.
