All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northeasterly side of Jonquil Lane, near the City of Greenville, S. C., being designated as Lot No. 28 on the plat of Cedar Lane Gardens as recorded in the RMC Office for Greenville County, S.
