to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Fred P. Styles, his heirs and assigns forever:

All that lot of land in Bates Township, Greenville County, State of South Carolina, lying on the southwest side of McAlister Street, near the Town of Travelers Rest, being shown as lot # 41 on a plat of the property of Ray E. McAlister, prepared by Pickell & Pickell, dated October 16, 1948, revised January 21, 1952, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the Southwest side of McAlister Street, front corner of lot # 40 which pin is 100 feet southeast of the intersection of said street, with Forrest Drive, and running thence with the line of lot # 40, S. 41-40 W. 251.9 feet to iron pin in the rear line of lot # 35; thence with the line of said lot, S. 51-16 E. 100.1 feet to iron pin at the rear corner of lot # 42; thence with the line of said property, N. 41-40 E. 246.8 feet to an iron pin on the southwest side of McAlister Street; thence with the southwest side of said street, N. 48-20 W. 100 feet to the beginning corner.

This being the same property conveyed to the grantor by deed of Ray E. McAlister dated January 26, 1954.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

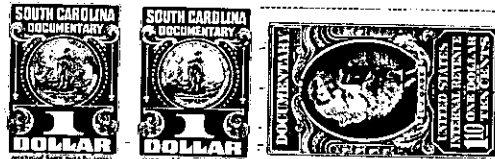
