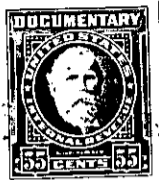
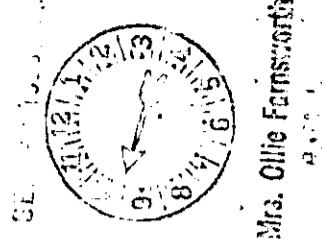

Greenville, County of Greenville, State of South Carolina, being known and designated

recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "Y"  
at page 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Pisgah Drive, joint front corner of  
Lots Nos. 65 and 66, Block D, and running thence N. 57-22 W. 150 feet to an iron pin,  
joint rear corner of Lots Nos. 65 and 66; thence N. 32-38 E. 70 feet to an iron pin,
