to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lawrence M. Nelson, his heirs and assigns forever;

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina in Gantt Township, being known and designated as Lot No. 63, as shown on a Plat of Brookwood, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Harvard Drive joint front corners of Lots 62 and 63 and running thence with the joint line of said lots, N. 2-15 E. 165 feet to an iron pin corner of Lot 72; thence with the line of said lot, N. 87-30 W. 100 feet to an iron pin rear corner of Lot 64; thence with the line of said lot, S. 2-15 W. 165 feet to an iron pin in the northern side of Harvard Drive; thence with said Drive, S. 87-30 E. 100 feet to the point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
