THIS is the same property conveyed to J. O. Bell, Jr., by deed of the Forfeited Land Commission of Greenville County, S. C., dated January 17, 1958, recorded in the RMC Office for Greenville County, S. C., in Deed Book 591, page 153, and is the South Carolina portion of that tract of land conveyed to Robert Montgomery and Lou Ella Montgomery by deed of John Goodwin, dated 1882, recorded in the Register of Deeds Office for Henderson County, N. C., in Deed Book 15, page 37. This property was conveyed to J. O. Bell by deed of S. D. Willis, Sheriff of Greenville County, dated January 6, 1921, recorded in the RMC Office for Greenville County, in Deed Book 60, page 387. J. O. Bell subsequently died intestate on October 17, 1939 in Henderson County, N. C., leaving as his sole heirs at law, the grantors herein, and F. D. Bell, who is executing a quitclaim deed to The City of Greenville, S. C., which is to be recorded herewith.

ALSO all interest which the Grantors have in and to any lands lying within the boundaries of any road or street, adjacent to, bounding or running through the above described property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
