in consideration of the sum of FOUR THOUSAND TWENTY FIVE (\$4,025.00)----- DOLLARS,

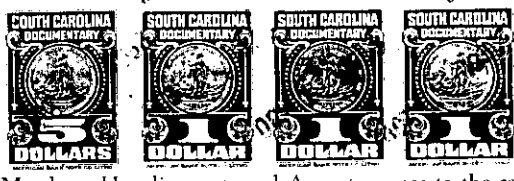

All that piece, parcel or lot of land in Chick Springs Township, County of Greenville, South Carolina, located on the East side of State Highway No. 14, near the City Limits of Greer, S. C., and being shown as all of lot number TWO (2) on a plat entitled "MAPLE HEIGHTS", made for Lee G. Smith Estate by H. S. Brockman, surveyor, dated Aug. 29, 1958, and recorded in plat ~~xxxx~~ book MM page 31, Greenville County R. M. C. Office, and having the following metes and bounds, according to said plat, to wit:
