P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 8 of the property of W. T. Patrick and William R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Nicholas Drive at the joint front corner of Lots 7 and 8 and running thence S 55-40 W 160 feet to a point at the joint rear corner of Lots 7 and 8; thence S 20-17 E 41.2 feet to a point at the joint rear corner of Lots 6 and 10; thence S 79-20 E 56.3 feet to a point at the joint rear corner of Lots 8 and 9; thence N 55-40 E 130 feet to a point on the Southwestern side of Nicholas Drive at the joint front corner of Lots 8 and 9; thence with the Southwestern side of Nicholas Drive N 34-20 W 80 feet to the point of beginning.
