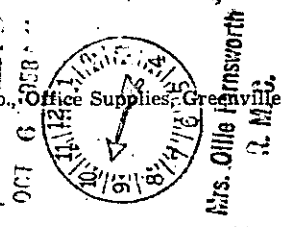

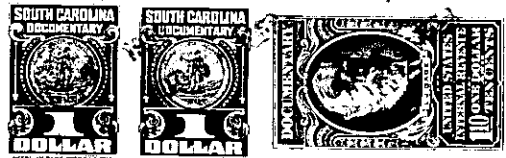

BEGINNING at an iron pin on Polk Boulevard, joint front corners of Lots Nos. 21 and 22 and running thence along the line of said lots, S. 70-40 E. 180 feet to iron pin, rear corner of Lots 12 and 13; thence running with rear line of Lots Nos. 12 and 11, 164.10 feet to iron pin rear corner of Lot 24; thence running with line of said lot, N. 70-40 W. 180 feet to iron pin on Polk Boulevard; thence running with said Boulevard, S. 20-40 W. 164.10 feet to iron pin at point of beginning.
