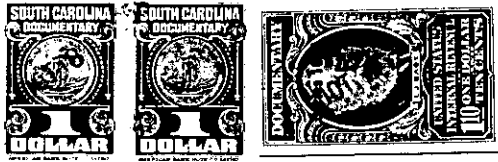
That C. E. LLOYD in consideration of the sum of (\$805.38) Eight Hundred Five and 38/100 in the State aforesaid, DOLLARS,
