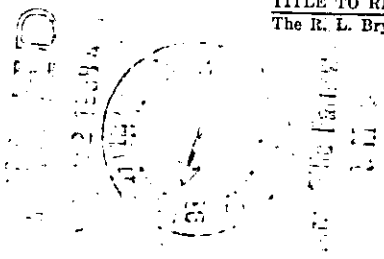

PIECE, PARCE OR LOT OF LAND IN GLASS Mt. TOWNSHIP, GREENVILLE
COUNTY, STATE OF SOUTH CAROLINA BEGINNING AT A ROCK CORNER
OF GEORGE BARTON AND SUDDUTH, RUNNING NORTH 11° 33' WEST 240 FEET
TO A SWEET GUM AT HEAD OF GULLY, THENCE NORTH 40° 40' EAST 322
FEET TO A ROCK OR OAK ON OLD ROAD, THENCE NORTH 41° 1' WEST
2700 FEET MORE OR LESS THROUGH GAP OF MT. TO A STAKE IN IVY
THICKET WEST OF OLD SCHOOL PATH CORNER OF SUDDUTH AND BATES,
THENCE NORTH 36° EAST 1000 FEET TO A LOCUST STAKE ON TOP OF MT.
THENCE SOUTH 70° 15' EAST 2970 FEET TO HEAD OF BRANCH AND DOWN
SAID BRANCH TO A BEND IN BRANCH, THENCE SOUTH 33° 10' EAST 300
FEET TO A STAKE ON BANK OF BRANCH CORNER OF BATES AND BATES,
THENCE SOUTH 4° WEST 700 FEET TO A HICKORY, THENCE SOUTH 33°
WEST 300 FEET TO A ROCK OAK GONE, THENCE SOUTH 10° EAST 250 FEET
TO ASH STUMP NEAR CREEK CORNER OF BATES AND BATES, THENCE SOUTH
30° WEST 2673 FEET TO THE BEGINNING CORNER CONTAINING 100 ACRES
MORE OR LESS.

OLD BARTON LINE TO THE BEGINNING CORNER CONTAINING 27 1/2 ACRES
MORE OR LESS.
