to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert D. Bass and Virginia W. Bass

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township, being known and designated as Lot Number Twenty-Five (25) according to a map or plat of Oakland Terrace as made by C. C. Jones and Associates, Engineers, in June 1957, which plat is of record in the R. M. C. Office in Plat Book "BB" at page 196, said lot of land being described by metes and bounds according to said plat as follows, to-wit:

BEGINNING at an iron pin on the Northwestern side of Zelma Drive at the corner common to Lots No. 24 and No. 25 as shown on said plat and running thence along the dividing line between said Lots No. 24 and No. 25 North 48-35 West 170 feet to an iron pin; thence South 41-25 West 100 feet to an iron pin at the corner of Lot No. 26; thence along the dividing line between Lots No. 25 and No. 26 South 48-35 East 170 feet to an iron pin on the Northwestern side of Zelma Drive; thence along Zelma Drive North 41-25 East 100 feet to the place of beginning.

This property is subject to the protective covenants set forth in an instrument recorded in the R. M. C. Office in Deed Book 586 at page 165.
