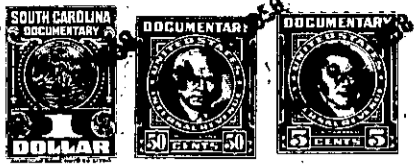

acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto  
the said Marvin R. Pollard and Ruby H. Pollard and their Heirs and Assigns forever,

All that certain piece, parcel or lot of land, located in Greenville County, O'Neal  
Township, State of South Carolina, and shown and designated as lot No. 13 on plat of  
property of D. E. Camp, said plat being recorded in R.M.C. Office in Volume FF  
at page 537, and being more particularly described as follows:

BEGINNING at joint corner of new cut road, lot no. 14 and lot no. 13, and runs thence  
N. 7-05 E. 24.5 feet to an iron pin, joint rear corners of lots nos. 13 and 14; thence  
N. 89-42 W. 90 feet to an iron pin, joint rear corners of lots nos. 13 and 12; thence  
S. 7-16 W. 234.5 feet to an iron pin, corner of lot 13 and 12 and new cut road; thence  
along and with the said new cut road S. 82-55 E. 90 feet to the beginning corner.

This being a portion of that property conveyed to grantor by deed dated 12 July 1952,  
and recorded in Book 461 at page 383.
