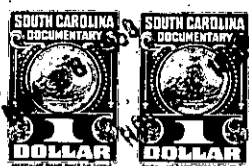

Gilstrap, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, on the Southeast side of Greenbrier Drive, being shown and designated as lot # 3 on a plat of Greenbrier Subdivision, and having according to said plat the following metes-and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Greenbrier Drive, front corner of lots # 2 and 3, and running thence with the line of said lots, S. 35-30 E. 221.4 feet to iron pin; thence S. 51-48 W. 100.1 feet to iron pin in line of lot # 4; thence with the line of said lot, N. 35-30 W. 226.1 feet to iron pin on the southeast side of Greenbrier Drive; thence with said Drive, N. 54-30 E. 100 feet to the beginning corner.

It is understood that this conveyance is made subject to restrictive covenants affecting all lots in this subdivision, said restrictions being recorded in the RMC Office for Greenville County.
