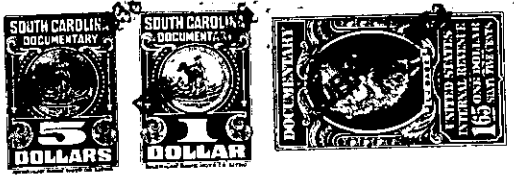

Know All Men by These Presents:

We, Joseph G. Mann, Individually and as Trustee for Alfred C. Mann, Jr., James R. Mann, Betty M. Jackson, John P. Mann and Thomas C. Mann in the State aforesaid, in consideration of the sum of Two Thousand Five Hundred Ninety and No/100 (\$2,590.00)--- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Oakvale Enterprise, a Corporation, its Successors and Assigns forever:

All those pieces, parcels or lots of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina and being known and designated as Lots Nos. 20 and 25 of Pecan Terrace Section 2, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "EE", at Page 108, and having, according to said plat, the following metes and bounds, to-wit:

LOT NO. 20: BEGINNING at an iron pin on the eastern side of June Lane at the joint front corner of Lots Nos. 19 and 20 and running thence along the joint line of said Lots S. 75-48 E. 155.2 feet to an iron pin; thence N. 14-12 E. 80 feet to an iron pin; thence along the joint line of Lots Nos. 20 and 21 N. 75-48 W. 155.2 feet to an iron pin; thence along the eastern side of June Lane S. 14-12 W. 80 feet to the point of beginning.

LOT NO. 25: BEGINNING at an iron pin on the western side of June Lane at the joint front corner of Lots Nos. 24 and 25 and running thence along the joint line of said Lots N. 75-48 W. 155.5 feet to an iron pin; thence S. 30-37 W. 47.1 feet to an iron pin; thence S. 31-49 E. 57.3 feet to an iron pin; thence along the joint line of Lots Nos. 25 and 26 S. 75-48 E. 128 feet to an iron pin; thence along the western side of June Lane N. 14-12 E. 85 feet to the point of beginning.

The above is a portion of the property devised to the grantors by A. C. Mann, deceased.
