Byrd Lucius Hammett, her heirs and assigns forever:

All that certain piece, parcel or lot of land, lying and being on the easterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 22 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Selwyn Drive at a point 133.9 feet north of the northeasterly corner of the intersection of Selwyn Drive and Spartanburg Road, said pin being the joint front corner of Lots 21 and 22, and running thence along the joint line of said lots N 84-16 E 167.8 feet to an iron pin in the line of Lot 47; thence N 2-03 E 90.85 feet to an iron pin in the line of lot 46, which pin is the joint rear corner of lots 22 and 23; thence along the joint line of said lots S 84-16 W 180.1 feet to an iron pin on the easterly side of Selwyn Drive; thence along the easterly side of Selwyn Drive S 5-44 E 90 feet to the point of beginning.
