Fore in the State aforesaid, in consideration of the sum of Four Hundred Ninety Five & NO/100 (\$495.00) - - - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mamie L. Ware; her heirs and assigns forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 124, as shown on a Plat of Lincoln Town near Paris, South Carolina, made by Dalton & Neves, Engineers, dated June 1945, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book S, at Page 39, and having according to said plat the following metes and bounds, to-wit:
