Simmerman and Virginia T. Simmerman, their heirs and assigns forever:

All that piece, parcel or lot of land, situate, lying and being on the western side of Biscayne Drive, near the City of Greenville, in the County of Greenville, State of S. C., and being known and designated as the rear portion of Lot No. 20, Section 2, of a subdivision known as Timberlake, Section 2, plat of which is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book BB, page 184, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the joint line of Lots Nos. 19 and 20, Section 2, which point is N. 89-07 W. 197.5 feet from Biscayne Drive, and running thence along the joint line of Lots Nos. 19 and 20, Section 2, N. 89-07 W. 34.8 feet to an iron pin; thence S. 19-37 W. 95.9 feet to an iron pin at the joint rear corner of Lots Nos. 20 and 22, Section 2; thence along the joint line of said lots, S. 87-07 E. 35 feet to an iron pin; thence along a new line through Lot No. 20, Section 2, N. 19-37 E. 96.2 feet to an iron pin, the point of beginning.
