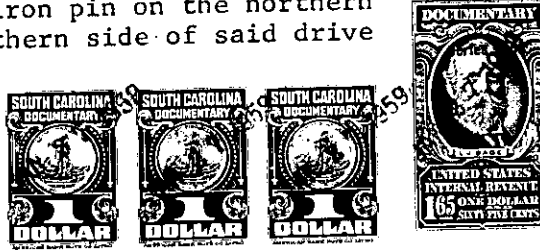
Know All Men by these Presents:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Gantt Township, being shown and designated as Lot No. 5 on plat of the property of W. H. Moore recorded in Plat Book KK, at Page 47, said lot being situate at the intersection of Hillcrest Drive and Berry Avenue and described as follows:
