ALL That certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the southern side of East Broad Street in the City and County aforesaid, having the following metes and bounds, to-wit:

BEGINNING At a point on the southern side of East Broad Street, which point is 67.6 feet in a westerly direction from the southwestern corner of the intersection of East Broad Street and Boyce Street, at the joint front corner of the property herein conveyed and the lot now or formerly owned by Kerr Wilson, and running thence along the common line of said lots in a southerly direction 80.5 feet, more or less, to a point in the northern boundary line of property now or formerly of Lillian D.
