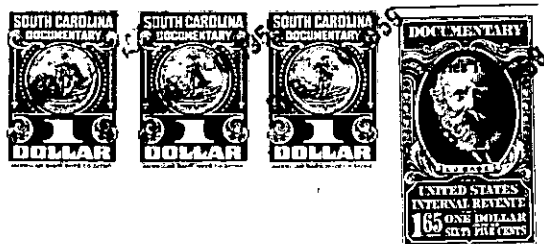
That I, C. F. Putman in the State aforesaid, in consideration of the sum of (\$1050.00) One thousand fifty & no/100 DOLLARS,
