Jeff Garrett in the State aforesaid, in consideration of the sum of One and No/100 (\$1.00) and love and affection for DOLLARS, my brother to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

G. Sidney Garrett, his Heirs and Assigns forever;

ALL my one-half (1/2) interest in that certain piece, parcel of lots of land, with the improvements thereon, lying, being and situate in the Town of Mauldin, State of South Carolina, County of Greenville, on the southern side of Pleasantdale Drive, being known and designated as Lots Nos. 4, 5 and 6 in property of T. Jeff Garrett and G. Sidney Garrett in accordance with Plat dated April, 1955 made by R. E. Jordan, and being more fully described in accordance with said Plat, to-wit:

BEGINNING at an iron pin on the southern side of Pleasantdale Drive, joint front corners of Lots 6 and 7 and running thence S. 13-15 E. 141 feet to iron pin; thence S. 5-52 E. 43.4 feet to iron pin; thence S. 84-13 W. 241 feet to iron pin; thence S. 78-58 W. 10.6 feet to iron pin; thence N. 13-15 W. 152.6 feet to iron pin on southern side of Pleasantdale Drive; thence N. 76 - 45 E. 255 feet to iron pin, being point of beginning.
