

BEGINNING At an iron pin on the Northeast side of Brookwood Drive, joint front corner of Lots 30 and 29, and running thence along the joint line of said lots, N. 70-32 E. 420 feet to an iron pin, joint rear corner of Lots 30 and 29; thence N. 1-08 E. 68.9 feet to an iron pin; thence N. 28-40 E. 202.5 feet to an iron pin, joint rear corner of Lots 29 and 28; thence along the joint line of said lots, S. 61-35 W. 616.0 feet to an iron pin on the northeast side of Brookwood Drive, joint front corner of Lots 29 and 28; thence along the Northeast side of Brookwood Drive the following courses and distances: S. 30-28 E. 51.5 feet; thence S. 23-20 E. 53.7 feet to the point of beginning, being a portion of the property conveyed to grantors by Mrs. E. H. Shanklin by deed dated July 22, 1946 and recorded in the Office of the R.M.C. for Greenville County in Deed Book 302 Page __290 .
