Oakvale Enterprise, its Successors and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, on the southwestern corner of the intersection of Augusta Road and North Wingate Road and being known and designated as Lot No. 9 of Pecan Terrace, Section 2, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "EE", at Page 108 and having, according to said plat, the following metes and bounds to-wit:
